**Gwen Kasero**

Gwen Kasero is a Supervisory Victim Specialist with the Bureau of Indian Affairs, Office of Justice Services Victim Assistance Program. She currently supervises the Victims Specialists stationed in New Mexico, southern Colorado, Arizona, Nevada, and Utah. Gwen began her career with the Bureau of Indian Affairs as a Victim Specialist in 2015, where she provided victim assistance to the Crow and Northern Cheyenne tribes in Montana, the San Carlos Apache Tribe in Arizona, and the Laguna Agency and Southern Pueblo Agency in New Mexico.

She was previously employed with the Pueblo of Laguna as a Crime Victim Witness Advocate for five years and a Social Services Specialist for two years. Gwen has earned her Bachelor of Arts degree in Psychology from Briar Cliff University in Sioux City, Iowa, a Master of Arts in Counseling from the University of New Mexico, and a master's in legal studies from the University of Oklahoma.

**Andrea Arnold**

Andrea Arnold is a Victim Specialist with the United States Department of Interior, Office of Justice Services, Bureau of Indian Affairs with a primary duty station on the Uintah & Ouray Ute Indian Reservation in Fort Duchesne, Utah. She has 8 years of experience providing direct services to victims of crime. Prior to serving as a Federal Victim Specialist, she served as the first Victim Advocate for the Utah Department of Public Safety, State Bureau of Investigation and assisted in developing the Victim Advocate Program for the Utah Highway Patrol and was assigned to assist in community policing by providing direct services to the homeless community during Operation Rio Grande in downtown Salt Lake City. In addition to providing direct services for the Utah State Bureau of Investigation and the Utah Highway Patrol, Andrea was the VINE (Victim Information & Notification Everyday) Program Manager for the State of Utah. While serving as the VINE Program Manager, she wrote for a 2.5 million dollar grant that was received for the State of Utah to upgrade the user technology platform that VINE utilizes. She is a graduate from the University of Utah with a Bachelor of Science majoring in Sociology with an emphasis in Criminology and a minor in Family Studies; with certifications in Criminology and Victim Advocacy/Family Violence. She has extensive experience in providing support to victims of crime in vulnerable populations in both urban and rural communities by building networks of collaborating services and resources throughout multiple jurisdictions to better serve victims of crime.

**Loretta Goldtooth**

Loretta Goldtooth is a BIA Victim Specialist, stationed at the Hopi Agency in Keams Canyon, Arizona since 2017. VS Goldtooth also covers the Supai and Kaibab Agency. VS Goldtooth provides direct services to victims of crime, in all three agencies. VS Goldtooth is a graduate of Northern Arizona University with a Bachelors in Social Work and Arizona State University with a Masters in Social Work.

**Robyn Simmons**

Robyn Simmons has been a BIA Victim Specialist assigned to the Mescalero Agency in New Mexico since 2011. Simmons provides direct victim services from the outset of a crime occurring and continued support and comprehensive services throughout the criminal justice process. Simmons earned a Master of Social Work degree from New Mexico State University and a Master of Legal Studies focusing on Indigenous People's Law degree from Oklahoma University. She is a graduate of the New Mexico Leadership program. Throughout her tenure with BIA, she received the United States Attorney's Office District of New Mexico Continued Appreciation Awards and the award for Outstanding Service on Behalf of Victims of Crime. Simmons is an enrolled member of the Mescalero Apache Tribe.

**Dr. Dheeshana Sugandhi Jayasundara**

Dr. Dheeshana Sugandhi Jayasundara is a Professor at the California State University, Fresno. She is very committed to pursuing transdisciplinary, innovative, and collaborative research endeavors. Her primary specialization involves working with vulnerable populations, such as Muslim, Rural, and Native American communities. A major aspect of her research examines the effects of culturally and community responsive trauma informed service delivery for survivors of gender based violence, and the impact of intersectional, contextual, and structural factors on gender based violence. She has advanced training in evaluation and advanced research methods with over 20 years of experience utilizing both formative and summative data. In all these projects, she uses Culturally Responsive and Equitable Evaluation (CREE) concepts. A major focus of her evaluation has been on the assessment, process, and impact of service delivery for gender based violence. She has served as the Primary Investigator and/or the evaluator of multiple large-scale research and evaluation projects. Her funded evaluation projects focus heavily on community engagement and the gender impact of development. For a number of years, she studied the impact of oil development on interpersonal violence in Western North Dakota and Eastern Montana. This research specifically looked at IPV prevalence, the nature of IPV violence, the barriers to services, and the implications to policy and practice related to oil impacted areas. She uses innovative community-based participatory action research models to bring about maximum community empowerment and change with policy impact. To bring about significant change, she has advocated at the funder, legislative, and community levels, in addition to presenting and writing for practitioner and academic audiences.

**Jayne Walters**

Dr. Jayme Walters is an Assistant Professor, BSW Program Director, and Director of Transforming Communities Institute (TCI) in the Department of Social Work at Utah State University. She was awarded her PhD from the University of Tennessee, College of Social Work in 2020. She earned her MSW and a certificate in Non-profit Organizations: Development and Management from the University of Georgia and BSW from Southern Illinois University-Carbondale. Dr. Walters also received a certificate in Fundraising Management from Indiana University, Lilly Family School of Philanthropy. Dr. Walters' main research regards quality of life in rural communities. She engages in community-level and organization-level research in the areas of poverty, social service provision, nonprofit capacity and management;

fundraising and philanthropy; macro social work education; and well-being of social workers. Her research has been published in Journal of Rural Studies and International Journal of Environmental Research and Public Health, among others. In the past two years of leadership, Dr. Walters led TCI from an initiative to institute status, as well as led the collaborative development and implementation of a new five-year strategic plan. Professionally, Dr. Walters was in the field as a social worker for nearly ten years prior to shifting into social work academia. Her roles included non-profit management, program development and evaluation, fundraising, and grant writing. Today, Dr. Walters works closely with communities and nonprofits to build capacity and provide research support. At the community level, Dr. Walters is currently involved in the development and implementation of a warming center in Cache County for individuals and families who are unhoused, as no homeless shelters exists within one hour of the community. Further, she serves as the new organization's vice chairperson of the Board of Directors and co-chair of the fundraising committee. Walters also engages significantly in professional service in the university, department, and discipline levels. At the university, Dr. Walters will serve as a representative for her college on the Institutional Review Board for the next few years, as well as a faculty mentor for Aggie First Scholars, a program for first-generation college students at USU. At the department level, Dr. Walters serves or leads several department committees, including scholarships, admissions, and communications. At the discipline level, Dr. Walters reviews for multiple social sciences and public health journals. Finally, she mentors undergraduate and graduate students in research regularly; in two years, she has mentored 13 individual students in gaining experience in developing and implementing scholarly projects. Personally, Dr. Walters grew up in poverty in the rural Illinois where she eventually became a first-generation college graduate, which fueled her passion for helping rural, persistently poor communities and economic and social justice. She is married to her husband, Jonathon, and they have one daughter, Kate.”

Teresa Larsen has completed her Bachelor's (2018) and Master's (2019) degree in Social work from Utah State University. After completing those degrees, she worked at the Center for Persons with Disabilities at Utah State as a project coordinator on multiple disability related projects, until she began pursuing her doctorate degree in Sociology in 2020. Through her education she learned the important dynamics of relationships and families. Kylyn started working in private practice, where she specializes in couples, families, adult and teenage individuals. She continues to see private practice clients currently, but mostly focuses on her day job as the Director of the Uintah/Daggett County Children's Justice Center.

Jessica has been trained in child forensic interviewing for over seven years, and conducted over 2,000 child interviews. Her interview training is with the Utah CJC Program Child Interview Guidelines, based on the National Institute of Child Health and Human Development ("NICHD") interview guidelines.

**Jessica Shelburg**

Jessica graduated with a Bachelor's Degree in Psychology and started her career in child welfare shortly after. Jessica first started in this field with the Division Child and Family Services as a Child Protective Services caseworker. As a CPS caseworker, she helped children and families maintain a safe home and family environment in cases where reported abuse/neglect occurred. The investigation of child abuse reports often involved domestic violence. This process frequently involved interviewing children using the forensic interview guidelines.

In 2019, Jessica became the Child Forensic Interview Specialist for the Uintah/Daggett Children's Justice Center. She is responsible for conducting most of the child forensic interviews and disabled adult interviews at the CJC for the Uintah/Daggett area, and occasionally courtesy interviews for other jurisdictions as well. She also participates in training colleagues from all over Utah to become certified child forensic interviewers, and helps her local team with staying up to date on their child forensic interviewing skills.

Within My Reach focuses on four Safety's needed for a relationship to be considered healthy... Physical, Emotional, Commitment, Community. The classes help participants begin to develop those skills by teaching processes for making smart decisions, discovering their strengths and weaknesses, identifying communication patterns that are dangerous, skillfully speaking, active listening, understanding forgiveness & when it's safe to reconcile a relationship or wise to move on, becoming aware of healthy commitment, recognizing the differences between how first families & complex families are formed, and finally how to reach their goals.

In this new role, Lindsey quickly became active in the community to better serve the victims of Duchesne County. She currently serves on the Local Homeless Committee, the Children's Justice Center Multi-Disciplinary Team, and on the Uintah Basin Association of Governments' Community Services Board as a representative of Duchesne County's low-income population. She helped
